Altum Resource Corp. Completes Initial Public Offering

Vancouver, British Columbia, March 27, 2020: Altum Resource Corp. (the "Company" or "Altum") (CSE: ALTM) is pleased to announce that on March 27, 2020, it completed its initial public offering (the "IPO") of 3,500,000 common shares in its capital (each a "Share"), at a price of \$0.10 per Share for gross proceeds of \$350,000. The Shares were approved for listing on the Canadian Securities Exchange on March 25, 2020 and are expected to begin trading on March 30, 2020 under the symbol "ALTM".
